The maximum expenditure that can be incurred under both section 137(1) and (3) for the financial year 2020-21 was £8.32 per elector.

Except for the matters reported below in my Basis for Qualification, on the basis of my review and subject to the matters and recommendations identified below, in my opinion no matters have come to my attention giving cause for concern that in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislation and regulatory requirements have not been met;
- is not consistent with the Council's governance arrangements; and
- that the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources.

Basis for Qualification

Accounting statement

In my opinion, the Accounting Statement does not properly present the Council's receipts & payments and statement of balances:

- The Council's fixed asset register is not complete and does not include assets that have been purchased in year.
