Materion yn Codi:</b></p> <p>(i) <u>Cyngor Sir Gâr</u> – Adran Priffyrdd - dim ymateb.</p> <p>(ii) <u>Cyfleusterau Cyhoeddus</u> – daeth tri swyddog o Adran Lle, Seilwaith a Datblygu Economaidd y Cyngor Sir i gyfarfod â chynrychiolaeth o'r Cynghorwyr ar 5ed Awst er mwyn trafod agor toiledau Pencader ac Alltwalis. Trafodwyd y les a chytunwyd y gellid ei dorri ar ôl 12 mis. Cytunwyd y byddai les newydd yn cael ei pharatoi.</p> <p>(iii) <u>Mynwent y Plwyf, Pencader</u> - nodwyd bod y gwaith atgyweirio ar doiledau Mynwent y Plwyf bron wedi ei gwblhau. Gofynnwyd i'r Clerc gysylltu â Rheolwr y cwmni sydd yn gwneud y gwaith i ofyn am ddyddiad i'w gyfarfod er mwyn trafod rhai materion.</p> <p>(iv) <u>Y Gofgolofn</u> - mae Abbey Masonary wedi addo dod i'w glanhau ddiwedd Hydref.</p> <p>(v) <u>Bancio</u> - nodwyd bod trefniadau bancio arlein wedi eu cwblhau erbyn hyn ac yn gweithio'n llwyddiannus.</p>	<p><b>5. Matters Arising:</b></p> <p>(i) <u>Carmarthenshire County Council</u> – Highways Department - no response.</p> <p>(ii) <u>Public Conveniences</u> - three officers from the Place, Structure and Economic Development Department of the County Council met with a representative number of Councillors on 5<sup>th</sup> August to discuss adopting the two sites. The lease agreement was discussed and it was agreed to include a break clause after twelve months. A new lease document will be prepared.</p> <p>(iii) <u>Parish Cemetery, Pencader</u> - it was noted that refurbishment work at the toilets in the Parish Cemetery is almost complete. The Clerk was asked to contact the Manager of the company undertaking the work to request a site meeting in order to discuss some matters of concern.</p> <p>(iv) <u>War Memorial</u> - Abbey Masonry have promised to clean the Memorial at the end of October.</p> <p>(v) <u>Banking</u> - it was noted that online banking arrangements have now been completed and are working successfully.</p>

<p>(vi) <u>Diffibrilwyr</u> - awgrymwyd i'r Clerc gysylltu â Jody Taylor-Williams (aelod o Bwyllgor Carnifal Pencader) i wneud trefniadau i drosglwyddo'r diffibrilwyr (a brynwyd gan Bwyllgor y Carnifal) sydd wedi eu lleoli y tu allan i dafarn y Bee-Hive a Siop Premier i restr y diffibrilwyr sydd yn cael eu cynnal a'u cadw gan Adrian Munday (wedi ei ariannu gan Fferm Wynt Brechfa).</p> <p>Cadarnhaodd M. Griffiths ei fod wedi cael trafodaethau gyda Paddlers Llandysul i ofyn eu caniatâd i gynnwys eu diffibrilydd ar y rhestr o ddiffibrilwyr sydd yn cael ei baratoi gan y Cyngor Cymuned i'w osod ar safle we ac hysbysfyddau'r Cyngor. Mae'r diffibrilydd hwn wedi ei osod ar wal y tu fewn i'w hadeilad yn bresennol ac mae trefniadau mewn llaw i'w ail-osod ar wal allanol. Nodwyd bod y rhain wedi bod mewn cyflwr gwael ers amser sylweddol.</p> <p>(x) <u>Yr Ardd Goffa</u> - gan fod y Cyngor wedi hysbysebu nifer o droeon ynglyn â'r gwaith o dorri'r coed o gwmpas y safle, ac nad oedd unrhyw un wedi dangos diddordeb mewn gwneud y gwaith, cynigiodd H. Lewis ein bod yn gofyn i Jason Thomas, (contractiwr lleol); eiliodd R. Thomas, a chytunodd pawb.</p>	<p>(vi) <u>Defibrillators</u> - it was suggested that the Clerk contact Jody Taylor-Williams (a member of the Pencader Carnival Committee), to make arrangements to transfer the care and maintenance of the defibrillators (purchased by the Carnival Committee) located outside the Bee-Hive Public House and Premier Stores to be included in the list of defibrillators maintained by Adrian Munday (funded by the Brechfa Wind Farm).</p> <p>M. Griffiths confirmed he had liaised with Llandysul Paddlers to ask if the defibrillator located at their premises could be included in the list of defibrillators currently being compiled by the Community Council to be placed on the Council's website and information boards. This defibrillator is currently located inside a building and arrangements are in hand to relocate it to an external wall of the property. It was also confirmed that maintenance is currently being undertaken by Adrian Munday (funded by Brechfa Wind Farm).</p> <p>(vii) <u>Bus shelters and white gates</u> - it was agreed by the officers from the Place, Structure and Economic Development Department of the County Council (at the meeting 05.08.2024 – see 5(ii) above), to arrange for the bus shelters and white gates within the parish to be cleaned during the next month.</p> <p>(viii) <u>Asset Register</u> - it was confirmed that the Asset Register has been updated and is now complete.</p> <p>(ix) <u>Noticeboards</u> - the Clerk reported that the noticeboard at New Inn has been repaired by Keith Lewis. With a proposal by G. Jones, seconded by W. Cole, Councillors agreed that the Clerk should also ask Mr. Lewis to attend to the noticeboards located at Alltwalis Cemetery and Pontwelly. It was noted that these boards have been in a state of disrepair for a considerable length of time.</p> <p>(x) <u>The Remembrance Garden</u> - as no response has been received, with the Council having advertised on several occasions in respect of cutting the trees surrounding the Garden, H. Lewis proposed that we ask Jason Thomas (local contractor) to undertake the work; R. Thomas seconded, and all agreed.</p>
